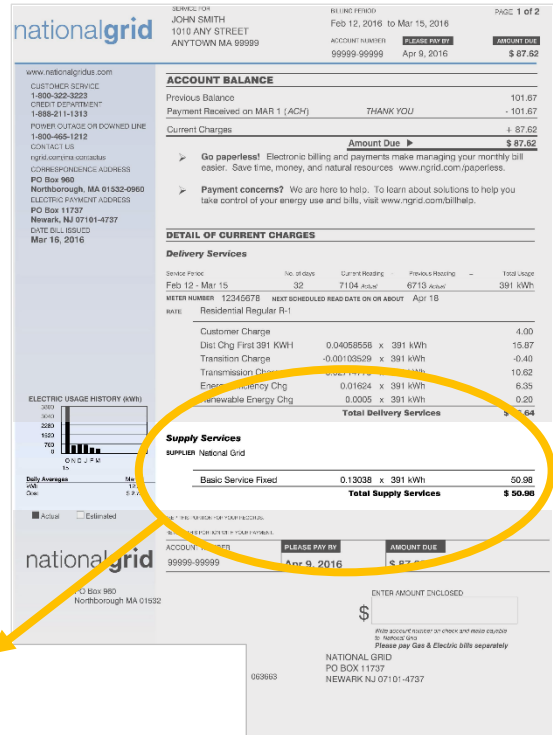
The Grafton Energy Choice program will change your supply price.
