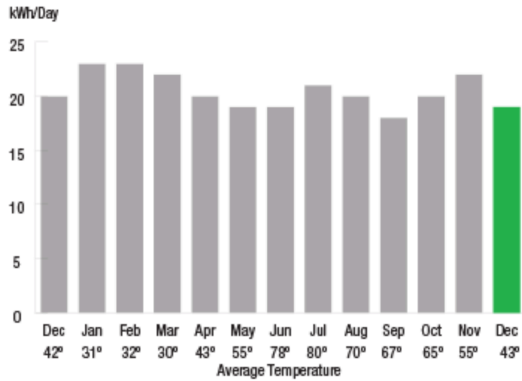

Electric Usage History - Kilowatt Hours (kWh)



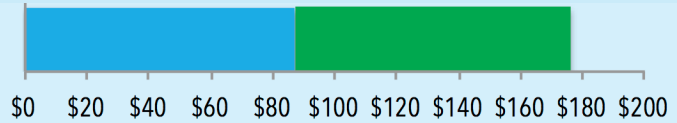
