By choosing the New England Green option, you make a greater contribution to driving the development of new renewable energy projects in New England by increasing demand for electricity generated by those projects.

Frequently asked questions

Will I remain an Eversource customer?

Yes. Your primary relationship for electricity will remain with Eversource. Eversource will still be responsible for addressing power outages and billing you.

What will change as a result of participating in Lexington's Community Choice Program?

You will see two changes on your Eversource electricity bill:

- The price used to calculate the supply charge portion of your bill will change to Lexington's Community Choice price
- Constellation will be listed as your electricity supplier

If I participate, can I change my mind later and leave the program?

Yes. You may opt out, or leave, the program at any time with no fee or penalty.

If I leave the program, can I join again later?

If you opt out of the program, you can join it again later, but you are not guaranteed the program price when you re-enroll.

If I want to finish my current electricity supply contract, can I join later?

Yes. You may join Lexington's Community Choice Program after your current contract ends. You will receive the program price at the time you join.

Are savings guaranteed?

No. Savings cannot be guaranteed. Lexington's Community Choice prices are fixed until December 2020, but Eversource's prices change every 6 months for residential and small business customers and

every 3 months for large business customers, so the difference between Lexington's Community Choice Program prices and Eversource prices will change over time.

Will I receive a lower quality of service from Eversource if I participate in Lexington's Community Choice Program?

No. Eversource makes money from the delivery charges on your electricity bill. They do not profit from the supply charges, so they have no preference as to whether they are your electricity supplier or you use a different supplier.

I am eligible for a low-income discount. Will I continue to receive it?

Yes. If you are eligible for a low-income discount from Eversource, you will continue to receive it.

I am currently on Eversource's budget billing. Will that change?

Yes. Budget billing will continue to apply to the delivery charge portion of your bill, but it will no longer apply to the supply charge portion. If it is important to maintain budget billing across your entire bill, you may wish to opt out of the Lexington's Community Choice Program.

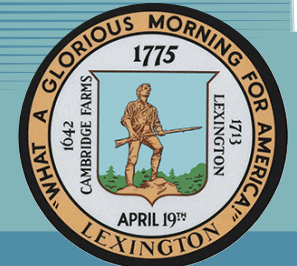
I have solar panels. Will I continue to receive net metering credits?

Yes. Your net metering credits will continue to appear on your Eversource electricity bill, and they will continue to be calculated based on Eversource's Basic Service price, not on Lexington's Community Choice Program price.

What kind of program is Lexington's Community Choice Program?

Lexington's Community Choice Program increases the amount of renewable energy in Lexington's electricity supply.

The program is a form of group electricity purchasing known as electricity aggregation.

Under this program, Lexington uses the bulk buying power of the community to:

- Select an electricity supplier for the community
- Buy more renewable electricity than the state law requires
- Provide electricity customers with electricity choices
- Obtain a stable price for electricity
- Secure customer protections



Electricity choices

Lexington's Community Choice Program provides Town-vetted alternatives to Eversource's Basic Service and to other electricity supply offers in the marketplace.

As a program participant, you will automatically be enrolled in the 100% Green offering and receive 100% renewable electricity — 11.624 cents/kWh for all electricity customers. The 100% Green offering includes 5% from renewable energy projects in New England in addition to the minimum amount required by the state.

You may also choose one of two other options:

- ▲ **Opt up to New England Green** and receive 100% renewable electricity all from renewable energy projects in New England — 12.428 cents/kWh for all electricity customers
- ▼ **Opt down to Basic** for renewable electricity that meets only minimum state requirements — 11.494 cents/kWh for all electricity customers

Program prices will be used to calculate the supply charge portion of your Eversource electricity bill. Eversource's delivery charges will not be affected by participation in Lexington's Community Choice Program.

Program prices are fixed until December 2020 meter reads.

Participating in the program

All new residential and commercial electricity accounts in Lexington on Eversource's Basic Service, meaning accounts that do not then sign an agreement with an electricity supplier, will be automatically enrolled in Lexington's Community Choice program, in the 100% Green option. This automatic enrollment model is state law. New electricity customers will receive a notification letter in the mail before being automatically enrolled.

Participation is not required. You may opt out of the program before being enrolled or any time after enrollment with no penalty.

If you opt out, the supply charges on your Eversource electricity bill will be calculated using Eversource's Basic Service price.

You have three ways to opt out before being automatically enrolled: **1)** Sign and return the reply card that you receive in the mail. **2)** Call Constellation at 1-844-813-7876. **3)** Opt out online at masspowerchoice.com/Lexington.

If you choose to participate, you may opt out any time after you are enrolled by calling Constellation at 1-844-813-7876 or online at masspowerchoice.com/Lexington.

If you are not enrolled in the program but wish to join, please call Constellation at 1-844-813-7876 and have your Eversource electricity account information available when you call.
