MUNICIPAL ELECTRICITY AGGREGATION PROGRAM NOTIFICATION LETTER

March 21, 2022

Dear Acton Electricity Service Customer,

I am writing to tell you about our Town's electricity aggregation program, **Acton Power Choice**. Through the program, Acton will increase the amount of clean, renewable energy in your electricity by an additional 10% over and above what you currently receive from Eversource. You may alternatively choose to get 100% of your electricity from clean, renewable sources, or to receive no additional renewable electricity.

You do not need to take any action to participate in this program. If you received this letter, you will be **AUTOMATICALLY** enrolled in the Acton Power Choice Standard offering at a price of **10.985 ¢/kWh** and receive 10% additional renewable electricity, unless you choose not to participate or choose another option. *(The back of this letter includes information about and prices for other program options.)*

You do not need to participate if you don't want to. **Your opt-out request must be postmarked by April 23, 2022, to avoid automatic enrollment.** You may also try the program out and opt out at any time in the future with no penalty or fee.

If you want to remain in the program...

If you want to remain in the program, Eversource will remain your electric utility. It will continue to deliver your electricity and send your electricity bill, and you will continue to call Eversource if you have a power outage.

Also, Acton Power Choice will change your electricity supplier to Constellation and will make two changes to your Eversource bill:

1. Your bill will list Constellation as your electricity supplier. The town has signed a contract with Constellation to supply electricity until September 2022.
2. Eversource will use the Acton Power Choice price (of the option you choose; see more on the back) to calculate the Supply charge portion of your bill instead of its own Basic Service price.

For comparison, Eversource's Basic Service price changes every 6 months for residential and small business accounts and every 3 months for large business accounts. In contrast, the Acton Power Choice price will not change until September 2022. The Acton Power Choice price does offer the potential for savings compared with the average of Eversource's Basic Service prices, but because future Eversource prices are not known, savings cannot be guaranteed.

Please note, if you are eligible for a low-income rate or fuel assistance, you will continue to receive those benefits if you participate in Acton Power Choice.

If you choose not to participate...

If you choose not to participate, Eversource will continue to calculate the Supply charge portion of your bill using their Basic Service price, as they do now, and your bill will continue to show Eversource as your electricity supplier, as it does now.





- If you do nothing, you will be enrolled in Acton Power Choice Standard.

- If you opt out, you will remain on Eversource’s Basic Service price. You may opt out now, before being enrolled, or you may participate and opt out later. There is no minimum participation period. You may opt out at any time with no fee or penalty.

* Acton Power Choice prices include a \$0.001/kWh administration fee. Program prices could increase as a result of a change in law that results in a direct, material increase in costs during the term of the electricity supply agreement.

** Eversource’s fixed Basic Service prices change every 6 months for residential & small business accounts and every 3 months for large business accounts. Eversource’s prices will next change July 1, 2022, for residential, small business, and large business accounts.

*** Eversource’s exit terms: Leave any time. No exit charge. However, large C&I (rates G-3, T-2, and WR) and street lighting customers on the fixed-priced Basic Service option may receive a billing adjustment, which may be either a credit or a charge.

Frequently Asked Questions

I have received this letter, and also I have recently signed a contract with an electricity supplier. What should I do? You may have signed your contract after this mailing list was created. In that case, you must opt out if you wish to retain your current contract. If you do not opt out, your account will be enrolled in Acton Power Choice, which may trigger early termination fees from your electricity supplier.

My organization is tax exempt. How to I maintain its tax-exempt status within this program? Taxes will be billed as part of the Acton Power Choice power supply charge. Customers are responsible for identifying and requesting an exemption from the collection of any tax by providing appropriate tax exemption documentation to Constellation.
